# SSC and AP appointments

The Council will review nominations for the Scientific and Statistical Committee (SSC) and Advisory Panel (AP) during Executive Session and the Chair will announce these appointments at the end of the meeting. Nomination materials, including letters of interest and a resume, are posted on the Council eAgenda nominations portal: https://meetings.npfmc.org/Meeting/Details/3051

All current SSC members are requesting reappointment, with the exception of Dr. Amy Bishop and Dr. Michael Jepson. Four new candidates have expressed interest in being appointed to the SSC for 2025: Dr. Hekia Bodwich, Dr. Jenn Burns, Dr. Emilie Springer, and Dr. Sarah Wise.

There were 21 members on the AP for most of 2024. Seven AP seats have 3-year terms that are expiring at the end of the year. Two seats are associated with resigning members – Brian Ritchie who was appointed to the Council, and Tim Heuker who is not requesting reappointment. The remaining 5 seats are held by members who are all eligible to be reappointed and are requesting reappointment (Tamara Briggie, Gretar Gudmundsson, Lauren Howard, Paul Wilkins, and Susie Zagorski). Additionally, three AP members (Tiffany Andrew, Nels Evens, and Annika Saltman) have served a 1-year orientation year that expires at the end of 2024, and these members are eligible to be extended into a full 3-year term.

The Council received nominations from 6 new candidates for appointment to the AP: Kiril Basargin, Bernie Burkholder, Craig Chythlook, Cheyanne Lambert, Michael "Chance" Miller, and Joshua Songstad.

## **CCC Update**

The Council Coordination Committee (CCC) met in Arlington, Virginia on October 16-17. Ms. Drobnica, Mr. Tweit, Ms. Evans and I represented the NPFMC at the meeting. Major topics of the meeting included updates on NEPA and ESA/MSA Integration policies, updates on IRA funding and National Seafood Strategy, a white paper on flexible status determination criteria, a workshop proposal from the EEJ Workgroup, as well as updates on fisheries science, budget, legislation, and progress of the different CCC workgroups. #### **MFAC Nominations**

Committee members are highly qualified, diverse individuals with experience in commercial, recreational, aquaculture, and non-commercial fisheries and businesses; seafood industry, including processing, marketing, restaurants, and related industries; marine, ecosystems, or protected resources management and conservation; and human dimensions or social sciences associated with living marine resources and working waterfronts.
